


9. All works will have to be done according to specification and drawing approved by authority and per direction of the Teacher-in-Charge, Hazi A.K.Khan College, Hariharpara, Murshidabad. Any deviation will be penalized. No Additional/ Modified work should be done without permission – however undersigned reserves right to modify scheme in public interest and tenderer shall cooperate and due payment for same, as decided by this Office, shall be paid to contractor.
10. No. consumable/Non-consumable materials will be supplied to the agency for any work from the office of the undersigned will not stand guarantee to any deal of contractor.
11. All rates should be inclusive of all charges, royalty, etc. ST/IT/PT/ and Cess/ Royalty will be deducted from contractor's bill.
12. Before starting the work site must be dresses and cleared by cutting all sorts jungle, shrubs etc for which no extra payment will be made.
13. Undersigned reserves the right to interact any clause in this notice including printing errors. Hence for any clarification, contact undersigned on any working day, preferably on prior appointment.
14. The applicant who do not purchase tender paper, after being selected by tender committee scrutiny, may not be allowed to purchase tender paper in two successive tender. However upon purchasing tender paper and going through Terms & conditions, contractor is free to decide on dropping.
15. The successful tender will have to start within seven days from the date of issue of work order after execution of formal agreement as per rule and will have to complete the work within the time allowed for completion. Work order have to be collected within seven days of opening of tender, otherwise officer may lapse and other contractor may given offer. No separate notice will be issued to successful tenderer, who will have liaison with this office and collect work order by hand.
16. Acceptance of the lowest tender is not obligatory & the tender committee reserves the right to accept or reject any or all the tenders in part/full without assigning any reason what so ever and also to split up the tender work to more than one contractor in the interest of scheme execution and also tender committee reserves right to enter into negotiation in public interest with any / all tenderers or outsiders, such negotiation will be generally held in first phase, at office of undersigned at noon on next working day after opening of tender. A notice in this regard will be displayed in office notice board and no other intimation will be sent, hence close liaison with office advised.
17. Amalgamation of unemployed Engineers Co-operative & Labour Co-operative. In any form should not be allowed towards counting of eligibility in participation of tender.
18. Any legal dispute will primarily fall within court jurisdiction of Murshidabad only in first change. For speedier resolution of dispute undersigned reserves to enter into arbitration as per Arbitration Act. And related rules, and such discretion if exercised by undersigned, will be binding on all participating tenderer. Any service of letter done by notice board and registered post A.D. will suffice as proper service in this regard.
19. This notice shall forms part of terms and condition of tender and tenderer shall be bound to abide by them if he drops Tender.
20. Before submission of the tender the contractor must visit the work site to judge the local condition from all concerned & no appeal complain about the site will be entertained after wards. It will be presumed that the agency offered the tender after reviewing entire position of the worksite and carefully going through work schedule / rate and terms and conditions.
- 21.(a) separate tender should be submitted in similar way for each work or group of work and separate tender paper used, to be issue on separate application if found eligible for each such tender paper for separate scheme.
- (b) Before submitting tender the tenderer must get his signature attested on the contact form by witness filling which his tender may be liable to be rejected.
22. All government rules and orders esp. W.B.F.R, W.B.(ZP & PS) A/C & rules as adopted by this office will apply and be binding on tender who participates.
23. The successful tenderer will have to abide by the provisions of West Bengal Contract Labour (Regulation & Abolition) rules 1972 or will be force from time to time. If no labour license is obtained are produced by the contractor payment will liable to be withheld.
24. If the requisite date as per schedule of dates & time is declared as holiday or mazor bandh/Bank strike occurs will be automatically increased to next working day and time will remain same.
25. Claim for idle labour from contractor will not be entertained under any circumstances. No claim will be entertained for any increase in Railway freight & market price act of good, natural/man-made disaster, local crime.
26. The tenders received after the due date & time and any change in quotation after opening of the tender will be automatically rejected. The department will not be responsible for the loss of tender form or for the delay in the postal transit.
27. The tender rate is valid up to 6(six) months after opening of tender and tenderer will keep this in mind while offering tender rate. No prayer for cost escalation, incidental entire cost will be allowed later, if work order is issued within this period.
28. For the rate of any supplementary items not provided in the tender, the same should be arrived at from item of printed schedule, P.W.D centre circle, if the items are not available in the schedule, the analysis may be made at fair market rates of the materials as directed by this Office.
29. The materials should be needed of the work should be stacked along road side of work and departmental officers are eligible to inspect the materials at any time for which no objection by the contractor will be entertained.
30. The sample of the supplying materials should be approved by the Teacher-in-Charge of the office before actual supply. All rejected materials should be removed from the site forthwith at tenderer's own cost.
31. each tenderer shall submit each NIT.
